

## **PROFILE OF SWPA POWER And Its Impact On Texas**

**Almost 1.5 million Texans** enjoy the benefits of clean, renewable and efficient hydropower generated at Corps of Engineers multipurpose reservoirs and marketed by the Southwestern Power Administration. SWPA power distributed to businesses and industry also supports **more than 270,000 jobs** in the state with a payroll of **almost \$5 billion annually**.

The power marketed by SWPA is generated at 24 Corps dams in the region, including four in Texas: Denison Dam/Lake Texoma, Robert D. Willis/B.A. Steinhagen Lake, Sam Rayburn and Whitney. In 2001 these four dams generated **607 million kWh** of electricity, or more than 13 percent of the energy generated by SWPA's system. SWPA customers, through their electric rates, will repay 29 percent of the entire cost of constructing these four lakes — almost **\$82 million** — *plus interest!*
